E. <u>BID OPENING DATE</u>

In order to be considered, the original and one electronic version on electric storage (CD or flash drive) of each bid must arrive at the issuing office by **November 22, 2017 no later than 2:00PM EST.** Vendors mailing bids should allow sufficient mail delivery time to insure timely receipt by the Strategic Sourcing and Acquisition Services. Vendors utilizing the U.S. Mail or similar methods which would not deliver directly to Room 02-100 of the Saratoga Street Offices are cautioned to allow sufficient time for the delivery to Room 02-100. Delivery of proposals to the campus mailroom or any location other than this office will NOT be considered "delivered" until they have physically arrived and have been clocked-in at the Strategic Sourcing and Acquisition Services. Bids or unsolicited amendments to bids arriving after the closing date and time will not be considered. Bids are to be sealed and are not to be e-mailed or faxed.

F. ACCESS TO ISSUING OFFICE

The Saratoga Street Offices, which houses the Strategic Sourcing and Acquisition Services, is accessible by the general public between the hours of 8:00 a.m. until 5:00 p.m. Monday through Friday with exception of legal holidays. There is a guard in the lobby area and vendors are required to sign in at the guard's desk and gain permission to enter the Office Levels of the building. H. <u>DURATION OF OFFER</u>

Prices quoted on the Price Sheet are to be inclusive of inside delivery, rigging, installation, training and all other requirements specified in this solicitation. There are to be no additional charges.

K. BID ACCEPTANCE

Further, the University reserves the right to make a whole award, multiple awards, a partial award or no award at all. By submitting an offer, the Contractor warrants that they have reviewed Appendix A (Commodities) and will execute a contract on that form upon request by University of Maryland, Baltimore.

A. <u>PURPOSE</u>

The overall purpose of this IFB is to provide information to vendors interested in preparing and submitting bids to meet the requirements for Five (5) Sterilizers described herein. Bids will be received for the items/services specified herein or attached hereto under the terms, conditions and general specifications of this IFB.

B. GENERAL INFORMATION FOR VENDORS

- 1. Bids must be made in the official name of the firm or individual under whom business is conducted (showing official business address) and must be signed by a duly authorized person.
- 2. Each bidder must furnish all information required by the IFB. Erasures or other changes must be initialed by the person signing the bid. Bids signed by an agent of the corporation must be accompanied by evidence of their authority.
- 3. This Invitation for Bids creates no obligation on the part of the University to award the contract or to compensate offerors for Bid preparation expenses.

C. <u>ADDENDA /AMENDMENT TO THE IFB</u>

If it becomes necessary to revise any part of the IFB, addenda will be posted to the eBid Board at www.umaryland.edu/procurement/ebid-board. It remains the responsibility of prospective Offerors to check the website frequently until the bid opening date for any addenda issued prior to the submission of bids.

H. PROCUREMENT REGULATIONS

This IFB and any resulting contract shall be governed by the USM Procurement Policies and Procedures and the State Finance and Procurement Article of the Annotated Code of Maryland and by State Procurement Regulations, Code of Maryland Regulations Title 21, as applicable.

I. MULTIPLE BIDS

K. <u>CONTRACTOR RESPONSIBILITIES</u>

The University shall enter into contractual agreement with the selected offering vendor(s) only. The selected vendor(s) shall be responsible for all products and/or services required by this IFB. Subcontractors, if any, shall be identified and a complete description of their role relative to the Bid shall be included. The University's intent is not to direct the use of any particular vendor, however, the vendor will not contract with any such proposed person or entity to whom the University has a reasonable objection. Notification of such objection will be made by the University within 15 days of contract. The vendor shall be fully responsible for the acts and omissions of its subcontractors and of persons directly or indirectly employed by them.

L. <u>PUBLIC INFORMATION ACT</u>

Offerors must specifically identify those portions of their Bids, if any, which they deem to contain confidential, proprietary information or trade secrets and must provide justification why such material should not, upon request, be disclosed by the University under the Public Information Act, , Title 4, General Provisions Article, Annotated Code of Maryland.

Vendors must clearly indicate each and every section that is deemed to be confidential, proprietary or a trade secret (it IS NOT sufficient to preface your Bid with a proprietary statement). This confidential and/or proprietary information should be identified Failure to comply may result in rejection of your Bid.

M. <u>MINORITY BUSINESS ENTERPRISE NOTICES</u>

Minority Business Enterprises (MBE) are encouraged to respond to this solicitation notice.

N. <u>ARREARAGES</u>

By submitting a response to this solicitation, a vendor shall be deemed to represent that it is not in arrears in the payment of any obligation due and owing the State of Maryland, including the payment of taxes and employee benefits and that it shall not become so in arrears during the term of the contract if selected for contract award.

The University of Maryland, Baltimore is exempt from Federal Excise Taxes, Maryland Sales and Use Taxes, and the District of Columbia Sales Taxes and Transportation Taxes, except as noted in applicable sections of COMAR. Exemption Certificates shall be provided upon request. Where a Contractor is required to furnish and install material in the construction or improvement of real property in performance of a contract, Contractor shall pay the Maryland Sales tax and the exemption does not apply.

R. MARYLAND PUBLIC ETHICS LAW, TITLE 5

The Maryland Public Ethics Law prohibits, among other things: State employees or officials (and in some cases, former employees) and businesses in which such an individual is employed or holds a financial interest from (i) submitting a bid or proposal, (ii) negotiating a contract, and (iii) entering into a contract with the governmental unit with which the individual is affiliated per §5-502 of the Maryland Public Ethics Law, Title 5, General Provisions Article, Annotated Code of Maryland.

S. HIPAA

Health Insurance Portability and Accountability Act of 1996, Pub. L. No. 104-191. ("HIPAA") and Maryland Confidentiality of Medical Records Act (Annotated Code of Maryland, Health – General Article '4-301 et seq. ("the Act"). Contractor acknowledges that the University of Maryland Baltimore is a HIPAA hybrid covered entity. Contractor shall also cause any subcontractor, agent, or party under Contractor's direction or control that is participating in this Agreement to promptly execute a standard HIPAA Business Associate Agreement if so requested by UMB.

IFB88595RE GLASS WASHER/DRYERS SECTION III SPECIFICATIONS

A. <u>BACKGROUND</u>

The University of Maryland, Baltimore is a public institution with the multiple missions of education, research and service. The 34-acre complex is located in downtown Baltimore, a city that has become a model for urban rebirth and vitality. The UMB complex has over 5,000 employees and approximately 6,000 students enrolled in seven professional schools: School of Dentistry, School of Law, School of Medicine, School of Nursing, School of Pharmacy, School of Social Work and Community Planning and the Graduate School.

B. <u>SPECIFICATIONS</u>

The following provides specifications and characteristics of the equipment/services and provider.

All materials, equipment, supplies or services shall conform to all applicable Federal and State laws and regulations and to the specifications contained in the solicitation.

The offeror shall submit with his Bid cuts, sketches, and descriptive literature and/or complete specifications. Reference to literature submitted with a previous Bid shall not satisfy this provision. Bids which do not comply with these requirements, are subject to rejection.

Vendors must comply with the following mandatory specifications. By submitting a quote the vendor is confirming that their equipment complies with these specifications.

Please quote on a Quantity of Five (5) new and unused research Glass Washer/Dryers with accessories per the following specifications.

Research Glass Washer/Dryers Specifications, HSF-III

Mandatory Requirements:

- A. Product Description:
- 1. The interior chamber size shall be minimum 27"W x 28"H x 27"D, \pm 1".
- 2. The overall dimensions shall be maximum 40" W x 78" H x 34" D, \pm 2".
- 3. The washer shall be designed for automatic single door vertical operation with a tempered full view window. The chamber and door shall be insulated. Doors equipped with sensor(s) to automatically retract (open) door if obstruction is detected in doorway. If power failure occurs, door can be manually opened.
- 4. The interior of the wash chamber shall be illuminated. Light shall be a 24 watt compact fluorescent light, mounted externally to illuminate the wash carrier.

- 5. Pre-wash treatment can be programmed to spray load with recirculated cold tap water. At the end of each treatment, drain discharge feature ensures water drained to the building drain system does not exceed 140°F (60°C). If water temperature in chamber sump is greater than 140°F (60°C), cold water is automatically added to reduce temperature of water being discharged to building drain.
- 6. Four tier manifold connectors that allow for varying height glassware. Connectors are double shut-off valves to allow for no flow without a rack. Racks are loaded through telescopic slides.
- 7. Two screens, located in bottom of wash chamber (sump), to prevent large debris from entering the piping system and pump. Both screens should be easily removable for cleaning.
- 8. Two adjustable peristaltic pumps to automatically dispense a selected amount of liquid chemical into the chamber sump during the specified treatment. Chemical to be located within sterilizer service area in 55 gal drum. Low level sensor to indicate when level in chemical container is low.
- 9. A water saver feature used to retain water used during the final rinse treatment is programmable for reuse during the first treatment of the next cycle. Water can be retained only if no chemicals were used during the final rinse treatment and if optional drying not selected. If retained water is too hot for reuse in first treatment of next cycle or if optional cold water pre-wash is selected, water to be automatically drained from sump.
- 10. Unit to provide damper to automatically remove vapor from chamber throughout the cycle.
- 11. The entire unit including cabinet and piping shall be fabricated of 304 stainless steel and all exposed surfaces to have a #4 finish. The pump shall be fabricated of the same material. All serviceable components should be accessible from a front access panel. Unit capable of meeting building code seismic requirements.
- 12. Integral pure water fill into washer. Pure water rinse treatment(s) will be recirculated through the main pump.
- 13. Stainless steel pump to deliver all treatments under pressure.
- 14. Internal battery to back-up all cycle memory for up to five years.
- 15. "K" Type Thermocouple to sense temperature inside wash chamber and pure water tank, and provide accurate control inputs and readouts throughout all cycles.
- 16. Safety door switch to prevent a cycle from starting if door is not fully closed, and to stop the washer operation if door is opened during a cycle.
- 17. The washing action should be accomplished by hydraulically operated stainless steel rotary headers and/or spindle headers. The wash chamber shall be fitted with quick locking device(s) for automatic connection of interchangeable headers to the pump recirculating piping. A pulsed detergent wash for restricted orifice glassware should be included.
- 18. Cycle Descriptions: Each cycle programmable with up to ten separate treatments.
- a. Pre-Wash: Load is sprayed with recirculated water at the selected temperature (selectable cold, hot or very hot) for a selected amount of time (0-9999 seconds). On completion of treatment, water is sent to drain.
- b. Wash: Load is sprayed with recirculated solution at the selected

temperature (selectable hot or very hot, in the sump, up to 190°F) for a selected amount of time (0-9999 seconds). A controlled amount of chemical detergent is automatically added to the chamber sump at beginning of treatment. If heated water is selected, treatment will not start until selected temperature is reached. On completion of treatment, solution is sent to drain.

- c. Rinse: Load is sprayed with recirculated water at the selected temperature (selectable hot or very hot, in the sump, up to 190°F) for a selected amount of time (0-9999 seconds). If Thermal disinfection option is selected, treatment will not start until selected temperature is reached. On completion of treatment, water is sent to drain.
- d. Reagent Grade Water Rinse: Load is sprayed with recirculated water at the selected temperature (ambient or heated, in the sump, to 190°F) for a selected amount of time (0-9999 seconds). On completion of treatment, water is either sent to drain or retained for use in the first treatment of next cycle.

 19. Unit shall be equipped with an integral manifold drying system consisting of a
- 19. Unit shall be equipped with an integral manifold drying system consisting of minimum 1/2 HP blower and electric heaters. System shall heat air up to 240°F. Drying time in programmable from 0-9999 seconds.
- 20. Unit shall be equipped with a full microprocessor control package that includes touchscreen, status displays and cycle end/low detergent audible/visual alarm to allow initiation, programming and monitoring of all cycle treatments.
- 21. Unit shall be equipped with an external Heat Exchanger to raise the building supplied hot water to 190F and an internal stainless steel steam coil to maintain solution temperature. Hot water will be fed by building system. Cool drain discharge to be less than 140F.
- 22. Supply the following accessory for startup:
- a. Quantity (1) 25 Position Spindle Rack in a 5 x 5 pattern capable of housing minimum 4" diameter glassware with a 4-3/4" high spindles with Teflon tips for protection of glassware. All spindles must have adjustable height devices to allow for varying height glassware.
- 23. Provide at the time of bid a complete list of headers and accessories, include unit prices.
- 24. Non-proprietary PLC control system that monitors and automatically controls all process operations and functions. Cycle phase times, temperatures and other key process parameters are programmable and may be locked in by supervisor. An 8 cycle menu of treatment processes may be programmed and retained to permit operating personnel to accommodate a wide variety of load and processing requirements. Cycle programming shall be controlled by access code to ensure process integrity. Each cycle program may be reviewed. The highly visible color 5" (minimum) TFT Touchscreen shall display cycle program data on demand and real time in process cycle performance. Programming may be in standard military time, temperature in Fahrenheit or Centigrade. Times and temperatures shall be expressed in minutes/seconds and degree increments respectively. An internal battery shall back up all cycle memory for up to one (1) year and permit completion of a cycle upon restoration of power after a power disruption. All cycle deviations are alarmed visually and audibly, recorded and must be acknowledged by the operator. A built-in service diagnostic program, accessible by service access code, shall be provided and displayed to permit system calibration and verification of satisfactory component operation. Provide a strip thermal printer with paper take up to record all cycle program and in process performance data. Must supply a USB port to allow Supervisors/Managers the ability to download current cycle data directly. The data is

automatically stored and dated and can be downloaded onto a computer, and printed using MS-Excel software.

- 25. Provide a digital copy of the backup program of both the PLC and Touchscreen in the event of a PLC or touchscreen failure, facility will be able to download the program into the PLC or Touchscreen.
- 26. For preventive maintenance testing and troubleshooting:
- a. Built-in service diagnostic program to permit system calibration and verification of component operations.
- b. Cycle/Day Count Recall System: To remind operator when a complete preventive maintenance check is required.
- c. Descaling Cycle: To remove scale and other hard water deposits from chamber and recirculation piping without the need for additional cycle programming. Factory programmed: user modifiable.

- 1. Reservation of Rights. This solicitation creates no obligation on the part of UMB. This solicitation may be cancelled at any time prior to opening of offers. UMB reserves the right to increase or decrease the quantities of any materials, equipment, supplies or services described in the solicitation. Offers may be modified or withdrawn by written notice received prior to the time and date set for opening. UMB reserves the right to accept or reject any and all offers in whole or in part. The University reserves the right to make awards by item, groups of items, multiple awards, or on an all or none basis as best serves the interests of the University.
- 2. <u>Pricing.</u> The unit price shall be considered as the offer price, which will be evaluated by UMB.
