The due date and time for the Technical Proposal has been updated to Friday, October 28, 2022 at or before 2:00 pm. Receipt of this addendum is to be acknowledged by completing the enclosed “Acknowledgement of Receipt of Addenda” form and including it within your Portfolio submission.

Clarifications:

1. The Deadline for Questions has been updated to **Friday, October 7, 2022 at or before 3:00 PM.**
2. The due date and time for the Technical Proposal has been updated to **Friday, October 28, 2022 at or before 2:00 PM.**
3. RFP Section III Article 1: Portfolio Requirements has been removed in its entirety. The Portfolio Phase is no longer part of this project.
4. All references to the “Portfolio Phase” are hereby removed.
5. All references to “Phase 2: Technical Proposal Requirements” are now referred to as “Technical Proposal”.
6. All references to “Phase 3 Technical Proposal Requirements” are now referred to as “Technical Proposal Requirements: Additional Information/ Oral Presentation”
7. The “Technical Proposal” requirements listed within RFP Section III Article 2 are now due on Friday, October 28, 2022 on or about 2:00 PM.
8. RFP Section 3.4.3 Portfolio Evaluation has been removed in it’s entirety.
9. The following language has been added to RFP Section 3.2.3.B Project Experience:

If a firm has multiple offices and/or locations, the design firm must only include those projects from the office(s) that will service this contract.

Question/Responses:

1. Please confirm if a MDOT certified small business (SBE) counts towards the MBE participation goals.

MDOT certified small business (SBE) firms do not count towards the MBE participation goals. Only those firms who are certified by MDOT as Minority Business Enterprise (MBE) businesses count toward the MBE participation goals.

2. We have a question regarding 3.1.1.B – “If a firm has multiple offices and/or locations, the design firm must only include those projects from the office that will service this contract.”. If two offices will service this contract (we are proposing team members located in two different offices), can representative projects for 3.1.1.B come from either/both offices?

Please note that RFP Section III Article 1 Phase 1- Portfolio has been removed in its entirety per Clarification #3. Clarification #9 has added modified language to the RFP in Section 3.2.3.B which addresses the question.
